## Documents required for opening **BALYA CHARAN** Account

- + Introduction from Natural / Legal Guardian / Principal of the School.
- + Photo ID Proof by way of Aadhar card / Identity Card issued by Educational Institution / Passport
- + Age proof
- + Proof of address of the Natural / Legal Guardian with a declaration that the minor is staying with them or resides in the same address. If the minor is staying in a Residential School or in a hostel, a letter confirming to that effect to be obtained from the Principal of the school / Warden of the hostel.
- + Declaration of Source of funds in the account either by the Minor or by the Natural / Legal Guardian
